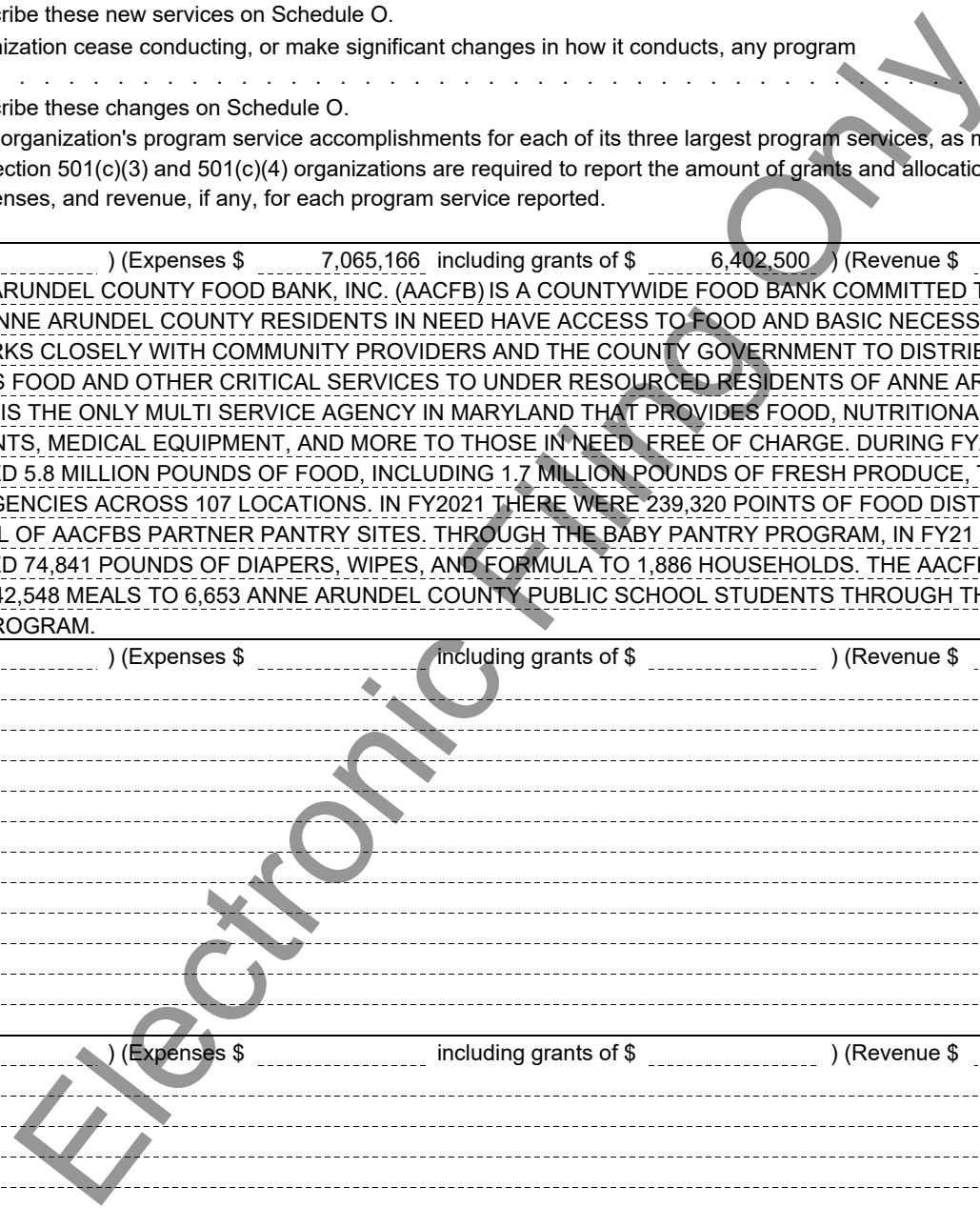

(AACFB) IS A COUNTYWIDE FOOD BANK COMMITTED TO ENSURING THAT ALL ANNE ARUNDEL COUNTY RESIDENTS IN NEED HAVE ACCESS TO FOOD AND BASIC NECESSITIES. THE AACFB WORKS CLOSELY WITH COMMUNITY PROVIDERS AND THE COUNTY GOVERNMENT TO DISTRIBUTE FREE, NUTRITIOUS FOOD AND OTHER CRITICAL SERVICES TO UNDER RESOURCED RESIDENTS OF ANNE ARUNDEL COUNTY. THE AACFB IS THE ONLY MULTI SERVICE AGENCY IN MARYLAND THAT PROVIDES FOOD, NUTRITIONAL SUPPLEMENTS, MEDICAL EQUIPMENT, AND MORE TO THOSE IN NEED FREE OF CHARGE. DURING FY2021, AACFB DISTRIBUTED 5.8 MILLION POUNDS OF FOOD, INCLUDING 1.7 MILLION POUNDS OF FRESH PRODUCE, TO 80 MEMBER AGENCIES ACROSS 107 LOCATIONS. IN FY2021 THERE WERE 239,320 POINTS OF FOOD DISTRIBUTION ACROSS ALL OF AACFB'S PARTNER PANTRY SITES. THROUGH THE BABY PANTRY PROGRAM, IN FY21 AACFB DISTRIBUTED 74,841 POUNDS OF DIAPERS, WIPES, AND FORMULA TO 1,886 HOUSEHOLDS. THE AACFB ALSO PROVIDED 42,548 MEALS TO 6,653 ANNE ARUNDEL COUNTY PUBLIC SCHOOL STUDENTS THROUGH THE BACKPACK BUDDIES PROGRAM.
